## Stay & Slay Packages

**Trial Host:** Alert K9 | **Trial Dates:** September 18-21, 2026 | **Trial Location:** Greenhill Lake Camp

**Given the limited availability of cabins & RV sites, priority will be given to those from out of town or are sharing.**

## ACCOMMODATIONS

### Platinum Package (Cabin accommodations, meals & breaks)

This competitor **is attending the full 4 days of the trial**, staying on site for 4 nights & having all meals & breaks (drinks/snacks) supplied. Included in the Platinum Package is:

- Check-in: Thursday September 18, 2026 after 2pm or Friday September 19, 2026
- 4 Nights in an on-site cabin
  - Can accommodate 2 people comfortably with dogs.
  - 3-4 sets of bunk beds; bathroom with sink, toilet & small shower; & a desk.
  - Each set of 2 cabins are adjoined. There is a lockable door between them.
  - Must provide your own bedding & towels.
- 4 Breakfasts (Friday, Saturday, Sunday & Monday)
- 4 Lunches (Friday, Saturday, Sunday & Monday)
- 4 Suppers (Thursday, Friday, Saturday & Sunday)

### Gold Package (RV site, meals & breaks)
